Re-visit of Surrey issued with a written statement of action from Monday 18 March 2019 to Wednesday 20 March 2019.

Ofsted and the Care Quality Commission (CQC) will carry out jointly a re-visit of your local area following the previous inspection that took place between 17 October 2016 and 21 October 2016.

The re-visit will evaluate how effectively leaders have addressed the areas of serious weaknesses detailed in the written statement of action (WSOA).

During the re-visit, Ofsted and CQC inspectors will be keen to speak to as many children and young people and their parents and carers as possible, <u>specifically</u> about the weaknesses identified in the WSOA.

Inspectors will reflect on the weaknesses outlined in the WSOA and will evaluate:

- whether statutory assessments and EHC plans are provided in a more timely way than they were in October 2016
- whether the quality and helpfulness of EHC plans has improved
- whether there has been improvement in the way that you and your children are involved in the planning, monitoring and evaluation of the local area's strategies and services
- whether the local offer is being promoted more effectively
- whether the efficiency and helpfulness of the local area's administrative processes has improved
- whether schools are better at identifying and meeting the needs of pupils with special educational needs and/or disabilities (SEND)
- whether the exclusion of mainstream school pupils with SEND has reduced since October 2016, and their attendance improved.

How can local children, young people, parents and carers contribute their views during this local area re-visit?

There are several ways in which children, young people, parents and carers from your provision can engage with the re-visit process and contribute their views.

The inspectors will gather the contributions of parents and families through an online survey and a face-to-face open meeting. The focus of the online survey and open meeting will be set by the inspectors and will be based on the WSOA.

- 2. An open meeting, which will focus on areas identified in the WSOA, will take place on **18 March**. Parents and carers can contact their local Parent Carer Forum to request details of how to be part of the discussions between parents and carers and the Ofsted/CQC re-visit team.

Details about the local area SEND re-visit will be available on your local authority's website and distributed through the local area's Clinical Commissioning Group/s (CCGs).

Information gathered during the re-visit

During this re-visit, inspectors may collect information about children and young people in the area. They may look at local area records, speak to area officers and leaders at educational settings, and speak to children, young people and parents or carers. No names will be recorded, but some of the information collected may identify a particular child, young person or adult. Ofsted and the CQC will use this information to prepare their re-visit outcomes letter, and for the purposes set out in their privacy notices. No information will be published that identifies any individual in the outcomes letter.
