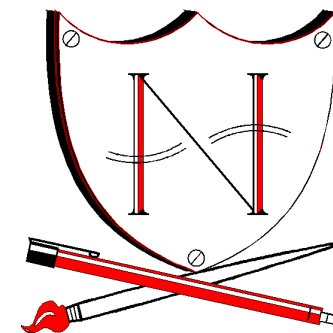

Welcome to
Northmead Junior School.

We hope you find your visit to our school informative and helpful. Before you enter the building we must ask you to take a few moments to read the information contained in this leaflet.

While visiting us you must wear your visitor's badge ensuring it is clearly visible at all times. You may be asked to show it to any of the staff or children if it is not easily visible.

We are proud of the safeguarding practice at Northmead Junior school. This leaflet will explain our expectations of all members of our community and our visitors.

Safeguarding Information

How do I ensure that my behaviour is always appropriate?

Appropriate relationships with children should be based on mutual trust and respect.

As a visitor or volunteer you may be working closely with children, sometimes on a one-to-one basis.

If you are working with a child on your own, always ensure the door is left open or that you are visible to others.

Do not photograph children unless you have been given permission by a member of the Senior Leadership Team.

Please do not use your mobile phone whilst on school premises.

Do not exchange emails, text messages or social media dialogue with the children and do not give out your personal details.

What if I am worried about a child?

If while working with a child you become concerned about:

Comments made

Marks or bruising

Changes in the child's behaviour or demeanor

Please report any concerns immediately to the Safeguarding Team.

Do not discuss your concerns with anyone else and do not promise that 'everything will be ok'

General Information

Fire and Emergency Evacuation

If the fire alarm sounds (continuous alarm) please leave the building immediately by the nearest exit and assemble on the playground.

Our staff will direct you.

In the unlikely event of a lockdown, 6 pulsing bells will sound. A member of staff will direct you to a safe place. Please be aware you will not be allowed to leave the building during a lockdown.

Accidents and Incidents

Please report these to the main office.

Access to the Internet

All users of the school systems and Wi-Fi must comply with our ICT Policy.

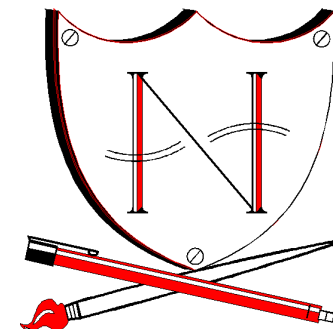
Please ask the office staff for details.
